- describing the common-law dispute-resolution systems and the role crossexamination plays in them
- explaining the rules of direct and re-direct examination and of cross-examination
- giving guidance about how to ask effective questions in direct, re-direct and cross-examination

SESSION 2: The Match In person, Milan

Saturday 11 November 2023

One or two trainers to a group of six trainees (i.e. three Claimant and three Respondent)

10.00-17.00 CET

- Trainees cross-examine witnesses in the mock *Bohemia v* Orange case
- Trainers review their cross-examination in the group (methodology: headnote, playback, reason, remedy, demonstration, replay)
- Individual trainers and individual trainees hold private reviews of a video of their cross-examination
