The tutors will be assisted by up to six local Chartered Arbitrators who will demonstrate to Fellows how they handle Hearings and will provide feedback on the Fellows' performances together with the tutors.

Entry Requirements

Candidates who wish to act as arbitrators must be FCI Arb.

The course is intended for candidates who:

- are intending to act as an Arbitrator.
- are intending to become a Chartered Arbitrator.

Candidates who wish to act as advocates in the mock hearings before the Chartered Arbitrators and Fellows need have no formal requirements but should feel competent to handle a complete series of oral hearings compressed into two days. Candidates who have attended the CI Arb / IAA advocacy training course on 24-25 November would be ideal.

Strictly Limited Places

The number of arbitrator delegates is strictly limited to a maximum of **12 people** (two groups of six) and this will therefore provide intimate training in a very small group for maximum benefit to the candidates. Places on the course shall be strictly on a first pay first served basis.

The number of advocate delegates is strictly limited to a maximum of **8 people** (two co-counsel per party per group). Places on the course shall be on a first pay first served basis.

The deadline for registration on the course is **10 October 2013** therefore payment of the course fee must be made by this date.

The cost of this course is heavily subsidised by the CI Arb and it offers a unique opportunity to Fellows to receive invaluable training of the arbitral arena from Chartered Arbitrators who have vast amounts of experience in conducting International Arbitrations. The course will provide clarity on the interactions between the members of a Tribunal and also the Parties' counsel.

Course Fee

The fee for arbitrators is AED 7,000 including lunch and refreshments. The fee for counsel is AED 7,000 including lunch and refreshments. Refunds are discretionary and based on the timing of a cancellation.

Social Event

After the course on Wednesday 27 November 2013 the candidates are invited for a social gathering in the Hotel from 6.00pm for an opportunity to network with the other candidates on the course and also the tutors.

Course Tutors



Mr Derek Wood CBE QC

Derek Wood has been a member of the set now known as Falcon Chambers since 1965. He has practised in all areas of property litigation since that date and appeared in many leading cases. He was appointed a Queen's Counsel in 1978 and has sat as a Recorder and Deputy High Court Judge. He is a Fellow of the Chartered Institute of Arbitrators and a Chartered Arbitrator. He is a Bencher of the Middle Temple and was Treasurer in 2006. He has served as chairman or member of various Government advisory committees on property, planning, transport and rating and has been awarded the CBE for services to property law. He was Principal of St Hugh's College Oxford from 1991 to 2002 and is an Honorary Fellow of St Hugh's College and University College Oxford. Between 2008 and 2011 he carried out reviews on behalf of the Bar Standards Board on the Bar Vocational Course, pupillage and Continuing Professional Development, is the Director of Advocacy in the Middle Temple and chairs the Research and Development Committee of the Advocacy Training Council.



Mr Richard Samuel FCI Arb Barrister

Richard was called to the Bar in 1996. For many years his practice involved him being in court every day of the week: on criminal and civil matters. Five years ago – some time after his practice had become purely commercial and his appearances in court and international arbitrations became longer and less frequent – he looked for a means of keeping his own advocacy match-fit. He found that opportunity training young barristers through his Inn of Court, the Middle Temple in London. He enjoyed the training because it forced him to think hard about his own advocacy and to keep improving it.

Richard found he learned most when invited to train lawyers from other jurisdictions. So two years ago he began the process of setting up the International Advocacy Academy (IAA) with Derek Wood QC to take the experience of English barristers to lawyers around the world for them to adapt to their particular circumstances and the international arbitration space in general.

Richard's practice at the Bar has for many years been general commercial litigation and arbitration, with an emphasis on directors' duties, offshore trusts and international trade. It includes employment, insolvency and professional negligence. He has acted in international arbitrations under the DIFC-LCIA, LCIA, RSA and UNCITRAL Rules.
